2017 FISH STOCKING PROGRAM

ALL ORDERS MUST BE RECEIVED WITH PAYMENT BY April 28, 2017

Scheduled DISTRIBUTION is May 4, 2017 from 11:00 a.m. to 12:00 noon

Distribution will be at the Monroe County Soil and Water Conservation District's office located at the County Fleet Center, 145 Paul Road. Distribution will take place behind the Soil and Water Conservation District Office (Building #5). The hatchery will deliver, distribute, and leave after this 1 hour distribution period. We have no holding facilities.

You must arrive during this distribution time or you will forfeit your order. NO REFUNDS.

PLEASE READ:

- 1) You **NEED** a Triploid Grass Carp permit to buy carp. If you do not have a permit, call the New York State Department of Environmental Conservation (NYS-DEC), Fisheries Office at (585) 226-5343 to obtain an application or download the form from the NYS-DEC website at: http://www.dec.ny.gov/docs/fish_marine_pdf/grasscarppermitappl.pdf or the District Website listed above.
- 2) Triploid Grass Carp control aquatic vegetation by consuming various types of soft stemmed rooted plants. Grass Carp will **NOT** control algae. Customers have been known to successfully use barley straw to reduce algae growth. For more information visit our website address above.
- 3) You may obtain a free Farm Fish Pond License to stock fish by calling the NYS-DEC Fisheries Office at (585) 226-5343. Permits are good for 5 years. This form is also available on the District website listed above.
- 4) You will need to bring 20 gallons of pond or lake water for every 6 Grass Carp, 30 Catfish, 500 minnows, 75 Perch, 50 Bass for 30-45 minutes of travel time. **Do NOT use tap water!** Using tap water will shock the fish.
- 5) Please bring a cover for the container(s) of water in order to reduce water loss while traveling. A garbage bag with a tie works best; this also keeps the fish in so that they don't jump out of the container.

PLEASE SEND YOUR GRASS CARP PERMIT (3 copies) WITH YOUR ORDER
(retain a photocopy for your records). This will enable us to expedite the distribution of your order.

You will receive a signed copy with your grass carp the day of distribution.

NO PERMIT=NO GRASS CARP
