Competition was intense between the twenty-two local high school teams registered for our local Envirothon, May 1st at Ellison Park. Each five-member team worked together as they were tested on their knowledge of five environmental topics including: Aquatics, Soils, Forestry, Wildlife and Current Issues (Sustainable Agriculture). Teams that participated included: Brighton, Brockport, Churchville-Chili, Eastridge, the Rochester City School District/Northeast College Prep and Our Lady of Mercy High Schools.

Brighton High School's Team 1 placed first overall and went on to compete at the New York State Envirothon at SUNY Morrisville placing 11th against 41 other county champions throughout the State. Congratulations Brighton High School!

Conrow Farms Named 2013 Conservationist of the Year and 2013 AEM Award Recipient

On April 12th, 2014, the District proudly named Conrow Farms as the 2013 Conservationist of the Year as well as the recipient of the 2013 Agricultural Environmental Management (AEM) Award at this year's Celebrate Agriculture Dinner. Conrow Farms has been in operation in the Town of Clarkson for 63 years and is run by Tom and Robert Conrow.

Since Conrow Farms began participating in the Agricultural Environmental Management (AEM) Program in 2010, they have successfully installed an Agrichemical Handling Facility for the storage and mixing of on-farm pesticides and fertilizers as well as a Fuel Secondary Containment Facility to hold and contain 3 bulk fuel storage tanks on the farm. Both projects were cost-shared through the Great Lakes Restoration Initiative program.

Conrow Farm's commitment to conservation goes beyond the farmstead practices that the District has completed on the farm, into the field, where the family follows sensible crop rotations and implements cover crops on their land to improve soil health and reduce erosion. They are active participants in the District's Agricultural Recycling Program and also follow principles of integrated pest management to help reduce the use of pesticides and overall risk to the degradation of water quality. Conrow Farms has also been a participant in the federal Conservation Stewardship Program (CSP) and Good Agricultural Practices (GAP) training program, and has worked with the MCSWCD for years on ways to correctly manage drainage on their lands. This farm serves as a good representative of a progressive family farm rising to meet the challenge of farming sustainably into the future.

Summer Fish Stocking Program—Save the Date!

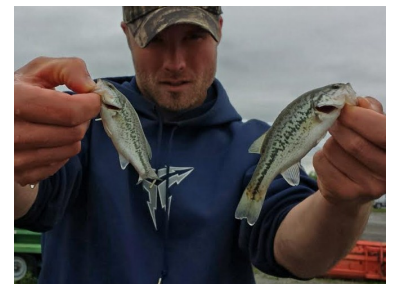


If you missed our Spring Fish Stocking Program, we can still accommodate your needs in our Summer Fish Stocking Program! We're scheduling our next distribution date for September 10th so please save the date. We'll be offering koi, fathead minnows, largemouth bass, yellow perch, catfish, and triploid grass carp within this next program.

For pond owners that are experiencing significant aquatic vegetation growth in their ponds, triploid grass carp can provide a non-chemical, environmentally-friendly control method.

IMPORTANT NOTE: triploid grass carp can only be purchased once you obtain a permit from the New York State Department of Environmental Conservation (NYS DEC). If you need that permit, please contact the NYS DEC office at: 226-2466 and ask for the Fisheries Department for details on applying.

The District's Fish Program is a pre-order program that requires pond owners to send in our order form and payment prior to the distribution so check our website for upcoming details regarding the program in August. EPA – Proposed Clarification of Waters of the United States Rule

The U.S. Environmental Protection Agency (EPA) and U.S. Army Corps of Engineers (Army Corps) recently jointly released a proposed rule to clarify protection under the Clean Water Act for streams and wetlands that form the foundation of the nation's water resources. The proposed rule will increase efficiency in determining coverage of the Clean Water Act. The proposed definitions of waters will apply to all Clean Water Act programs. It does not protect any new types of waters that have not historically been covered under the Clean Water Act.

Specifically, the proposed rule clarifies that under the Clean Water Act:

- Most seasonal and rain-dependent streams are protected
- Wetlands near rivers and streams are protected
- Other types of waters may have more uncertain connections with downstream water and protection will be evaluated through a case specific analysis of whether the connection is or is not significant



The proposed rule preserves the Clean Water Act exemptions and exclusions for agriculture. Additionally, EPA and the Army Corps have coordinated with the U.S. Department of Agriculture (USDA) to develop an interpretive rule to ensure that 56 specific conservation practices that protect or improve water quality will not be subject to Section 404 dredged or fill permitting requirements. Any agriculture activity that does not result in the discharge of a pollutant to waters of the U.S. still does not require a permit.

2014 Conservation Tree & Shrub Program Reaches More Than 400 Local Landowners!

Let's start with THANK YOU!!! Our 2014 Conservation Tree and Shrub Program is closed for this year and we're pleased to say that we reached a total of 429 landowners while distributing 23,100 trees, shrubs and plants this spring. We very much appreciate those that participated and will continue to offer this program for those interested next year.



It's our goal to provide an opportunity for landowners to continue toward improving their property by providing a variety of programs and services, one of which is our Tree and Shrub Program. Offering these trees, shrubs and plants helps support conservation planting projects, wildlife enhancement, erosion control and windbreak development needs throughout the area.

While we made several changes in our program offerings this year, we will begin the process for our 2015 program soon and hope to bring back popular species along with new species to consider. This year there were 28 individual tree, shrub, and plant species offered with an addition 37 species available in our plant variety packs. Popular species offered for the first time in 2014 were: Winterberry, River Birch, Sweet Crabapple, Black-eyed Susan, Wild Geranium and we launched a new multi-pack for Hummingbirds and Honey Bees.

This would not have been possible without the help of our volunteers and the Monroe County Department of Environmental Services. Thank you!
